# House Bill 3665 – Joe Coleman Act

Joe Coleman Act (Medical Release) was enacted into law on January 1, 2022. This Act gives the Illinois Prisoner Review Board the sole discretion/authority to release medically infirm or disabled individuals in custody.

## 2022 Joe Coleman Filing Process

An application can be filed under the Joe Coleman Act by: Individual in custody, Prison official, Medical Professional who has treated or diagnosed the individual in custody, Attorney, or an individual in custody's spouse, parent, guardian, grandparent, aunt, uncle sibling, or child over the age of 18 years. The individual in custody must consent to the application if he/she are not the one filing the application.

Once an application has been received via fax, email or mail, the application is reviewed for completion. All applications that are deemed complete, per the guidelines, will have a Healthcare request sent over to the medical unit at the holding correctional facility. Healthcare requests are reviewed by a doctor or nurse practitioner within the healthcare unit and returned to the Illinois Prisoner Review Board within 10 days, providing a diagnosis, prognosis, likelihood of recovery, primary symptoms, to include incapacitation and any additional medical information that is deemed important for the Board to take into consideration. Along with healthcare information, the doctor/nurse practitioner will also evaluate whether the applicant qualifies under at least one of the following required three criteria:

- A. Is suffering from a terminal illness, which the condition is likely to cause death to the individual within 18 months;
- B. Has been diagnosed with a condition that will result in medical incapacity within the next 6 months;
- C. Has become medically incapacitated subsequent to sentencing due to illness or injury.

Should the doctor/nurse practitioner determine that the applicant does not meet at least one of the above criteria, no hearing will be conducted by the Board and a notification will be sent back to the applicant, or representative advising that the application is considered nonqualifying.



## The Joe Coleman Hearing Process

Applications that are deemed qualified by the doctor/nurse practitioner at the holding correctional facility, will be prepared for a hearing by the Board. A public hearing is not needed but may be requested by the applicant and if so, hearings are conducted regularly throughout the months via Webex. The board send notifications to the applicant, or their representative, the State's Attorney of the convicting county(s) and any registered Victims of the hearing and the deadline date for any additional documentation to be considered and registration details for public hearings. These notifications also allow the State's Attorneys and registered Victims to provide a response to the application for the Board to take into consideration.

Hearings are conducted by a three- member panel on scheduled hearing dates. Once a hearing is complete, notification will be sent to the above mentioned, providing the Board's decision. If an applicant is denied, they can refile another application after six months from the date of the decision.

If an applicant is granted release by the Board under the Joe Coleman Act, the applicant will be release on a mandatory supervised release for a period of 5 years subject to Section 3-3-8 of the statute, which shall operate to discharge any remaining terms of years imposed upon the applicant. In no event shall the eligible person serve a period of mandatory supervised release greater than the aggregate of the discharged underlying sentence and the mandatory release period as set forth in Section 5-4.5-20 of the statute.

The board received 182 applications that were nonqualified due to not meeting one of the following criteria:

A. Is suffering from a terminal illness, which the condition is likely to cause death to the individual within 18 months;

C. Has become medically incapacitated subsequent to sentencing due to illness or injury.

The board requested and received a total of 260 medical statements from the healthcare unit in the Department of Corrections.
