Summary of discussion for parole consideration: Member Bowers presented a summary of the parole interview and a review of all file materials. Mr. Aldridge was interviewed on June 27, 2012 for parole consideration. He is now 63 years old and serving 90-120 years for murder. He is currently medically unassigned, receives no visits, and is coming off a three year set. He has consistently denied to participate during his interview. He has served 36 years. Facts of the crime were reviewed. They indicate that he sexually assaulted the sixteen year old victim and shot her multiple times. He declined to discuss the crime.

His parole plans are none. He has no family and no outside support. He is confined to a wheelchair. He has obtained his GED while incarcerated.

He indicated no remorse and declined to talk about the offense.

Protest from the State's Attorney is noted and was reviewed. There is also protest from the victim's family. They indicate that Aldridge is a sexually-sick cold-blooded murderer.

Motion to deny parole that release would depreciate the seriousness of the offense and promote disrespect for the law. (EB – ABD)

Motion carries 13-0.

Board members felt that they would not vote favorably in the next five years and noted the lack of continued cooperation and lack of any parole plan.

Motion for a five-year set. (EB - ABD)

Motion carries 13-0.

Summary of discussion for parole consideration: Member Crigler presented a summary of the parole interview and a review of all file materials. Mr. Sterling was interviewed on May 30, 2012, his attorney and family members were also present. Facts of the crime were reviewed and discussed. They indicate that Sterling met his codefendant and they decided to go to a public aid office and get some guns. During the course of the robbery, two security officers were shot and killed. Mr. Sterling indicated that he was nineteen years old at the time and make bad decisions. He has no previous criminal history or gang affiliation before entering DOC. He stated that he joined the gangs because it was the way of life in the prison and then in the mid 1990s he attempted to denounce them but he had to snitch to DOC and he wouldn't do that. He expressed great remorse and indicated that he prays consistently. He has had many achievements while incarcerated. His family history was reviewed. His parole plans are to live with his sister and her husband in Chicago and work with his brother in an auto service distribution.

Past parole votes were reviewed. He is now 57 years old and served 38 years. He shot the security office, two officers were shot, and the plan was to steal weapons. There was lengthy discussion regarding the shooting and what happened to the officer's gun. The protest letter from the SA was read as well the Rule 23 decision.

Gang involvement was also discussed. He was a board member of the gang. Some members felt his involvement was minimal and others substantial.

Motion to go to Closed Session pursuant to 5 ILCS 120/s(c)(18) for deliberation for decision of the Prisoner Review Board. (EA – CF) Motion approved 13-0 The Board went to Closed Session. The Board returned to Open Session.

Inmate Name: Willie Sterling IDOC Number & Institution: C60246

CLARIFICATIONS -

State's Attorney Office – It was clear that his codefendant escaped. The first victim, Legros, was shot first by the codefendant. It would defy common sense that Sterling would not have known the first victim was shot. And then he shot the second victim.

Aviva Futorian – The first victim was shot in a different room and Sterling has always maintained that he didn't hear it. The motive that this was for future robberies is not correct. There is no evidence that he ever did anything violent in the gang and that he was appointed education leader. He would live with his sister, which is not a gang neighborhood. His application for parole plans to St Leonard's is pending. He is remorseful and has turned to religion.

Member Crigler stated that she feels punishment and rehabilitation has been satisfied. His education, vocational, and support indicate that he is a good candidate for parole.

Motion to grant parole as he is an acceptable risk (EC - CF).

Summary of discussion for parole consideration: Member Findley presented a summary of the parole interview and a review of all file materials. Mr. Peter is serving 90-180 years for the murder and rape of a fourteen year old girl, his original sentence was death. The facts of the crime were reviewed. They indicate that the victim accepted a ride from Peter. He sexually assaulted her and murdered her.

While incarcerated he has had many accomplishments. A past letter in his file regarding employment was noted. He asked the board to recognize that he has changed and become a person of value. His DOC record is absent of violence. Documents in support of parole were noted.

Motion to go to Closed Session pursuant to 5 ILCS 120/s(c)(18) for deliberation for decision of the Prisoner Review Board. (EA – CF) Motion approved 13-0 The Board went to Closed Session. The Board returned to Open Session.

Discussion continued – There was some discussion regarding the Attorney General and their evaluation for SVP. It was determined that an evaluation had not been done yet and is cannot be done until DOC determines that the inmate is 90 days from release or requested.

His criminal history was reviewed and it revealed other rapes. His institutional adjustment has been good. He is now 62 years old. The victim was 14 years old.

CLARIFICATIONS -

State's Attorney – Peter is a recidivist and while on bond he actively attempted to attack another girl. He is a predator and kept trophies and they are disturbed by the lack of remorse.

Peter's Counsel – She noted the additional documents provided and board members acknowledged that they had received them. She also requests a more in depth psychological report.

Due to all factors listed above, motion to deny parole in that to release this inmate would depreciate the seriousness of the offense and promote disrespect for the law. (CF - JM).

Summary of discussion for parole consideration: Member Parrack presented a summary of the parole interview and a review of all file materials. Tolefree was interviewed on June 27, 2012. He is serving 30-100 years for rape. He has served 34 years and is now 63 years old. Facts of the crime were reviewed. In May 1977, the victim was throwing her trash away and as she tried to enter her apartment, Tolefree pushed in behind her. He knocked her to the ground, beat and threatened her, and raped her. He then raped her a second time. Tolefree indicated that he was in the apartment building because he was invited by a friend to play chess. He has sex with her, not consensual, but he didn't threaten her and she was not scared but relaxed.

Motion to go to Closed Session pursuant to 5 ILCS 120/s(c)(18) for deliberation for decision of the Prisoner Review Board. (JP - JM) Motion approved 13-0 The Board went to Closed Session. The Board returned to Open Session.

His criminal history was reviewed. He has received 175 disciplinary (12 sexual misconduct) tickets. He is currently in segregation. He has received his GED. He stated that he attended sex offender counseling, but refused to participate. His parole plans are with his brother in Plainfield or with his sister in Chicago. He plans to work for his brother in janitorial.

There is concern with the number of tickets he receives, he denies all but a few and stated that he loves women.

He is a risk to re-offend.

State's Attorney – they are requesting a five year set.

He is in a A grade and hasn't received a ticket since 2009. His criminal history was reviewed. His parole plans are to University Park with his ex-wife. Protest letters from the State's Attorney and former prosecutor were reviewed. Time served is a concern, he has not yet served the minimum. It took a substantial amount of time to solve this case and he could have chosen indeterminate sentencing.

Motion to grant parole in that to release is an acceptable risk. (GT - EA).

The ears of both victims were cut off. The man survived for two days, but died in the hospital. The woman and her son survived. Mr. Glenn stated that it was suppose to be a typical robbery that went crazy. He did not remember why he committed the crime and stated things got out of hand. He was sixteen years old at the time. This was a brutal crime. He expressed remorse.

He has not utilized programs while incarcerated, but he has been assigned consistently. He has no parole plans and wants to go back to East St. Louis. His last ticket was in 2008.

He has a lack of parole plans and this was a serious crime.

Due to all factors listed above, motion to deny parole in that to release this inmate would depreciate the seriousness of the offense and promote disrespect for the law. (ADM – EA).

He brutally beat the victim, who hours before helped him do laundry.

His parole plans are to a halfway house.

Protest from the State's Attorney was reviewed. The victims are scared of him, he knows the family. His girlfriend was pregnant and he needed money for an abortion, they felt he was going to rob her. They are asking for a five year set. He stated that he did not remember the crime, and was an alcohol and LSD user. A recent psychological report indicates basically nothing, no further services needed at this time. In talking with him he sees fit. His DOC record was reviewed.

CLARIFICATION -

State's Attorney – He was on probation at the time. The victim's son is very fearful, found the victim in the bloody bathtub. Ross did pursue an insanity defense, which was rejected.
